Emergency overview

Over-exposure signs/symptoms

Large spill

Handling

Storage

Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. 8. Exposure controls/personal protection
